We are the place to turn for help when life's problems seem overwhelming and too difficult to handle alone. Our life-changing services give hope to those struggling with family crisis, child abuse, traumatic events, emotional disorders, mental illness and addictions.



**CALL CENTER**

Our intake and appointment specialists provided a single point of entry for **33,090** new callers who sought help for abuse, trauma, children's mental health, parenting, counseling, adult mental health and addictions.

**COUNSELING SERVICES**

Our highly trained therapists helped **10,836** adults, children and families understand problems, identify strengths, encourage positive relationships and improve overall functioning.

**FAMILY LIFE EDUCATION**

Because positive parenting can make such a difference in the life of a family, we offered a variety of parenting and relationship enhancement classes to **12,856** parents and couples last year.

**DIVORCE SERVICES**

Our Families in Transition staff, housed in the Tulsa County Courthouse, assisted **19,787** families and their children going through difficult and high-conflict divorce.

**CHILD ABUSE AND TRAUMA TREATMENT**

Our specially trained therapists helped **5,700** children and their families recover from the trauma of being sexually abused, victimized, physically hurt or emotionally harmed.

**FAMILY PRESERVATION**

Our family preservation program strengthened **256** high-risk families through home visitation programs. Services reduced child abuse and assisted with reunification following out-of-home placement of children. We also facilitated adoption for **562** children in Oklahoma Department of Human Services custody.

**CHILDREN'S MENTAL HEALTH**

We used a variety of evidence-based treatment approaches to treat emotional, behavioral or relational problems for **8,250** children and their families last year. Therapists provided office-based as well as school-based services at 25 local schools.

**EARLY CHILDHOOD FAMILY SUPPORT AND MENTAL HEALTH SERVICES**

In partnership with the Community Action Project of Tulsa County's early childhood education and Head Start programs, F&CS helped **8,392** children and their families, linking them to community resources and providing parenting support and mental health consultation.

**PSYCHIATRY AND BEHAVIORAL HEALTH SERVICES**

We made recovery from serious mental illness possible for **6,584** individuals through psychiatry, case management, counseling and other specialized services.

**SUBSTANCE ABUSE AND ADDICTIONS**

In several outpatient settings, we gave **346** individuals the resources, supports and treatment options necessary to develop sober living, coping and relapse prevention skills for recovery.

**DIVERSION SERVICES**

Our staff—along with the court, the Department of Corrections and other treatment providers—diverted **402** individuals with mental illness and addictions from unnecessary incarceration and helped them successfully integrate into the community.

**WOMEN IN RECOVERY**

This new and innovative alternative to incarceration program helped **56** non-violent female offenders achieve recovery, community integration and reunification with their children.

**COMMUNITY OUTREACH PSYCHIATRIC EMERGENCY SERVICES (COPES)**

Our mobile crisis intervention team provided 24-hour rapid response, stabilization and intervention for **6,000** adults and children in crisis.

**CHILD PSYCHIATRY**

**1,002** children and adolescents with severe emotional and behavioral difficulties were seen by F&CS child psychiatrists for mental health care, psychiatric evaluation, consultation and, if needed, medication.

**HOMELESS PROGRAMS**

We reached out to **700** mentally ill, homeless individuals and their families, offering mental health care, substance abuse treatment and linkages to housing and other community resources.

**PHARMACY**

Our convenient, on-site pharmacy provided our uninsured clients with **108,895** prescribed psychiatric medications, valued at almost \$13 million.

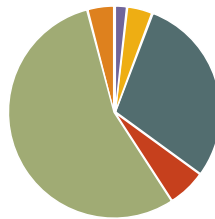

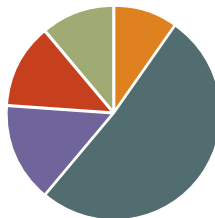
