# CHILD ABUSE AND TRAUMA TREATMENT

Our team of child trauma specialists works with children to restore their well-being following traumatic life events, including sexual abuse, neglect, loss of a loved one, witnessing violence and other catastrophic occurrences.

# CHILDREN'S COUNSELING & MENTAL HEALTH PROGRAMS

Our compassionate professionals provide children and families with individually tailored services, in schools and at our offices, to help your child overcome a wide range of emotional, behavioral or relationship problems—from mild to severe.

# ADD/HD SCREENING

We provide screenings to find out if your child's difficulties are due to ADD/HD. Once determined, we can offer treatment options and referrals for medication evaluation.

# CHILD PSYCHIATRY

Children and adolescents with severe emotional and behavioral difficulties—who are being seen in the agency for mental health care—can be referred for psychiatric evaluation, consultation and, if needed, medication.

# COPES FOR KIDS—COMMUNITY OUTREACH **PSYCHIATRIC EMERGENCY SERVICES**

Our team provides 24-hour rapid telephone response, stabilization and, when needed, mobile services in Tulsa County for children and teens who feel out of control or have thoughts of suicide, harming themselves or hurting others. Call 918.744.4800.

# **COUNSELING SERVICES**

Our highly trained therapists help adults, children and families understand problems, identify strengths, encourage positive relationships and improve overall functioning.

# **FAMILY PRESERVATION**

We promote positive parenting through home visitation programs designed to strengthen overburdened families who are at risk for child abuse or neglect or are reunifying following out-of-home placement of children.

#### **FAMILY LIFE EDUCATION**

Because positive parenting can make such a difference in the life of a family, we offer a variety of parenting and relationship enhancement classes to parents and couples.

# **DIVORCE SERVICES**

If you're experiencing a difficult or high conflict divorce, our staff will provide valuable solutions for you and your family.

# EARLY CHILDHOOD FAMILY SUPPORT AND MENTAL HEALTH SERVICES

In partnership with Community Action Project's early childhood and Head Start programs, we provide parenting support and mental health consultation.

# OUTPATIENT MENTAL HEALTH AND SUBSTANCE ABUSE SERVICES FOR ADULTS

# PSYCHIATRIC TREATMENT AND MEDICATION

Comprehensive psychiatric evaluation and medication management is provided for adults with severe mental illness following an intake evaluation.

# CASE MANAGEMENT

Caring advocates will help you strengthen relationships and link you to needed mental health, community resources and health services.

# **OUTPATIENT THERAPY AND GROUP SERVICES**

An array of individual therapy, group education services and therapy groups are provided to enhance day-to-day functioning and recovery while improving relationships, self-confidence, coping skills and the effective management of grief, stress, anger, anxiety and depression.

#### TRANSITIONAL CARE

We provide transitional care for clients discharged from psychiatric hospitalization to ensure continuity of care to outpatient treatment.

# SUBSTANCE ABUSE AND ADDICTIONS

In several outpatient settings, we give you the resources, support and treatment options necessary for recovery through the development of coping, sober living and relapse prevention skills. DUI assessment and classes are also offered.

# **HEALTH AND WELLNESS**

A small, onsite medical clinic, wellness programs and care coordination help clients in our mental health programs manage and improve overall health.

# **ALTERNATIVE DIVERSION PROGRAMS**

Drug court, mental health court, Assertive Community Treatment, re-entry and homeless outreach help those with both serious mental illness and criminal justice involvement divert from long-term hospitalization, jail or prison.

# WOMEN IN RECOVERY

This highly specialized, day treatment diversion program helps eligible females facing incarceration for substance abuse offenses achieve recovery, self-sufficiency and reunification with their children.

# **CRISIS SERVICES**

Our 24/7 CrisisCare Center provides evaluation and short-term crisis stabilization in a secured, safe and caring environment for adults experiencing an emotional, behavioral or psychiatric emergency. Call 918.744.4800.

CRISIS RESPITE CENTER (up to 24 hours)
Offers psychiatric care for up to 24 hours in a therapeutic, supportive and calming setting.

CRISIS STABILIZATION UNIT (up to 5 days) A 16-bed therapeutic unit helps those experiencing a severe mental health crisis stabilize and begin recovery.
